Client shall ensure that: (A) A song request form is completed for any special requests within 14 days of scheduled event; (B) DJ is provided with a sturdy, covered 6' or 8' DJ table within 25' of a 3 prong grounded electrical outlet; (C) the place of engagement is open and available to the DJ at least one (1) hour before the scheduled starting time; (D) the place of engagement meets all state and federal safety regulations; (E) for all outdoor performances, unless waived by the DJ, a tent or similar overhead protective covering must be provided to prevent damage to the DJ's equipment in the event of adverse weather conditions; (F) reasonable steps will be taken to protect the DJ and his equipment & music collection from any type of abuse, theft or damage resulting from this booking. In the unlikely event of circumstances deemed by the DJ to present a real or implied threat of harm to the DJ's equipment, music or person, the DJ reserves the right to cease performance until the Client has resolved the threatening situation. (G) The DJ reserves the right to deny any guest access to the DJ's music and/or equipment.

Rhyme4Reason Entertainment shall ensure that: (A) we will comply with all federal, state, and local laws and ordinances; (B) we will cease performance immediately upon direction of law enforcement authorities, or Client; (C) we will remove all personal equipment and property from the performance site within one (1) hour following the end of the performance or such reasonable time agreed by both parties.

PERFORMANCE WAGE AND DEPOSIT: As agreed upon, the price for services will be _____ plus all applicable taxes of _____ for Rhyme4Reason Entertainment services. Rhyme4Reason will impose traveling fees should your event occur outside a fifty mile round trip radius. Traveling fees include but are not limited to mileage, tolls, and parking. If your organization is tax exempt please provide your tax exemption number: _____. Within 14 business days upon acceptance of this agreement by both parties, a non-refundable deposit of \$100.00 of the purchaser's price is to be paid by Check/Transferrable Funds. This deposit is to be payable to Rhyme4Reason. The remainder of the balance is due at the end of the event, payable to Rhyme4Reason in the form of cash, money order, or certified check.

INSURANCE: Employer agrees to retain any and all necessary personal injury or property damage liability insurance with respect to the activities provided by Rhyme4Reason on the premises authorized by this agreement. Employer agrees to indemnify and not hold Rhyme4Reason accountable for any and all claims, liabilities, damages, and expenses arising from any action or activity of Rhyme4Reason while Rhyme4Reason is rendering the specified contracted services, except for claims arising from Rhyme4Reason's willful misconduct or gross negligence.

CANCELLATION: In the event that the Employer cancels scheduled appearance a written notification must be received no later than thirty (30) days prior to the event and the deposit will be forfeited as liquidated damages. If the Employer cancels the scheduled performance within two weeks before the date of such performance, the Employer will pay Rhyme4Reason, as liquidated damages, the full purchase price as agreed upon within this contract. Rhyme4Reason will not be responsible for any cost incurred to the Employer in the event of a cancellation.

Should Rhyme4Reason cancel due to unforeseen circumstances Rhyme4Reason will either reschedule a performance with 10% off initial agreed upon performance price or the Employer will be refunded their full deposit. Performances are subject to termination in the event of sickness, accident, riot, strikes, epidemic, acts of God, or other legitimate conditions beyond our control.

DISPUTES: If any disputes arise under this Agreement that results in litigation or arbitration, the prevailing party shall be paid by the losing party for its attorney's fees and associated costs.
